**Connecting to Purpose- Patient Story/ Organizational Success:** L. Nabb, Vice-President Clinical Services shared that a new Rapid Access Addictions Medicine (RAAM) was opened at the end of May through a collaboration with services from the Family Health Team, Mental Health and Addictions Services, and a partnership with St. Joseph's Care Group in Thunder Bay. RAAM Clinics provide wrap-around care, including access to physicians who can assess, prescribe and treat underlying addictions concerns. All clinics to date have been full, with patients sharing that it has already made an impact by encouraging patients who have struggled with other programs in the past.
